- 1 My involvement and/or participation in the **#ShakeIt for Self-Acceptance!**TM awareness event and rehearsals is **voluntary**, and I am acting under my **own free will**. I have not been compensated nor will I further be compensated for participation in said event.
- There is a risk of danger, bodily harm, injury, emotional stress or death as a result of my participation in #ShakeIt for Self-Acceptance!TM awareness event, including but not limited to, practices, and rehearsals therefore said event, with or without fault or negligence of myself or Alli Spotts-De Lazzer (DBA Shake It Up! Accept Yourself). I hereby release, waive, indemnify, discharge, and covenant to hold harmless from all liability Alli Spotts-De Lazzer (DBA Shake It Up! Accept Yourself), from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me.
- I attest that I am fully aware and accept there are known, unknown and unforeseeable risks and hazards connected with being on the premises and rehearsal locations while participating in the #ShakeIt for Self-Acceptance!TM awareness event. Accept Yourself) and her agents in perpetuity from any and all claims and causes of action that I or my representatives now have or may have in the future (including but not limited to) for personal injury, property damage or wrongful death occurring to me or my property, arising out of participation in the #ShakeIt for Self-Acceptance! waveness event and rehearsals. I also agree to indemnify, defend and hold Alli Spotts-De Lazzer (DBA Shake It Up! Accept Yourself), and/or her representatives, its subsidiaries, affiliates, officers, agents, employees and partners harmless from any liability, claim, demand, administrative action, cause of action, suit, damage, loss, cost or expense, including reasonable attorneys' fees, made any third party due to or arising out of my participation in the #ShakeIt for Self-Acceptance!
- 9 I am 100% liable for all medical expenses incurred as a result of any injury or property damage during my participation in the #ShakeIt for Self-Acceptance!TM awareness event and rehearsals.

I understand that all disputes in regard to this agreement will be settled by binding arbitration in the County of Los Angeles at a mutually agreed upon location.
- 12 I understand that this is a public event and that photographs, audio and/or video recording may be taken. I hereby acknowledge and agree that all rights, title and interest in and to said photographs and recordings, including all copyright rights, shall belong solely Alli Spotts-De Lazzer (DBA Shake It Up! Accept Yourself), her agents and assignees, and I hereby grant the right to use my likeness, both still image and recorded moving image with and/or without audio, as recorded during my participation in this event and rehearsals, in perpetuity, to Alli Spotts-De Lazzer (DBA Shake It Up!
