Accept Yourself (“Organizers”), **the undersigned (“Participant”), for themselves, their heirs, assigns and legal representatives, hereby expressly agrees to the following:**

1. EXPRESS ASSUMPTION OF RISK. I agree to **assume any and all risks involved, whether known or unknown, in or arising from my participation in the Event** including, without limitation, the risks of death, permanent disability, bodily injury, property damage, lost property, and stolen property resulting from any activity relating to the Event, including but not limited to collision between his or her person and another participant’s person, an object, or barrier, a trip and fall, and any other occurrence while engaging in any activity during the Event.

I hereby acknowledge and agree that **all rights, title and interest in and to said photographs and video/audio recordings, including all copyright rights, shall belong solely to Organizers**, their agents and assignees, and I hereby grant the right to use my likeness, both still image and recorded moving image with and/or without audio, as recorded during my participation in Event, in perpetuity, to Organizers for any and all purposes related to the Event including, but not limited to, advertising and promotion of iaedp™ and/or the #ShakeIt for Self-Acceptance!® movement without compensation or control thereover.
